It is proposed to infill between the main house and store increasing the floor area of the store by 6m.sq. The existing shell of the store is to remain with the insulation applied internally. To accommodate the requirements of the building regulations it is proposed to raise the flat roof by 450mm providing an eaves height of 2650mm. The property has not been extended since construction.
